SUBMISSION GUIDELINES

- i. Poster write-up, applications for exhibition opportunity and abstract should not have more than 300 words. It should be submitted via the submission link provided below.
- ii. Abstracts should highlight the sub-theme, title, a brief introduction of the problem, objective(s), methodology, key findings, conclusions, practical implications, and 5 keywords.
- iii. Each abstract should include the names of the author(s), affiliation(s), e-mail and telephone contacts. The corresponding author and email address must also be indicated.
- iv. Each full paper should have (4000-5000) words, single-spaced, font size 12, Times New Roman; Tables and Figures inserted near where they are first cited, and MS-Word typesetting.
- v. All references cited in the text should be listed alphabetically following the APA 7th edition style. All the references listed in the paper should be cited appropriately in the text using APA 7th edition style
- vi. Papers that are already published are not acceptable
- vii. All papers selected for presentation will be peer-reviewed and will be published in the KLISC Journal.
- viii. All papers selected for presentation will be peer-reviewed. The best papers from this conference which meet the publication criteria will be published in the KLISC Journal.
